
#### What's Included:

#### Overview:

Step back in time to Victorian England in this fully interactive and dramatic workshop that allows pupils to explore crime, justice, and community in the 1800s. This session combines role-play, creative expression, and historical enquiry - perfect for bringing topics like local history, the Victorians, or law and order to life.

#### What's Included:

- 1. **Interactive Courtroom Role-Play:** Pupils re-enact "The Stolen Purse", a scripted mock trial where each student has a role to play, promoting teamwork and public speaking.
- 2. **Suspect Drawing Activity:** A fun Identikit sketch session where students create images of the suspect using witness descriptions.
- 3. Three Rotational Group Activities:
  - Character Cards: Each pupil will be given a photo card of a person featured in the museum. They have to find who they are, and discover their past!
  - Cell Tours: Explore our authentic Victorian jail cells on a guided tour.
  - Q&A with a Police Officer: An opportunity to meet and ask questions to a retired police officer.

# Package 3: Courtroom Workshop + Museum Tour

**Post-Visit:** Schools are provided with post-workshop discussion points, and a teacher resource to support further learning back in the classroom

#### Overview:

Engage older students in a critical exploration of justice, ethics, and decision-making in this sophisticated courtroom drama workshop. Participants adopt legal roles, build persuasive arguments, and work together to deliberate and deliver a verdict on real-world-inspired cases.

#### What's Included:

#### 1. 90-minute Courtroom Drama Workshop:

- Pupils perform "The Green Dress" or "The Final Step", two scripted trial simulations. More information about the subject of each trial is found below.
- Roles include prosecution, defence, jury, witnesses, and defendant fostering critical analysis and public speaking.

#### 2. Optional 30-Minute Post-Workshop Discussion:

 Includes discussion prompts and teacher notes to guide further reflection in class or onsite.

#### 3. 1-Hour Museum Tour:

• Explore our original cells, courtrooms, and exhibition spaces in small guided groups.




### The Trials



#### **The Green Dress**

Step into a 1958 Bradford courtroom in The Green Dress, a powerful educational workshop that blends immersive theatre with critical historical inquiry. Written by one of our experienced volunteers, who has over 40 years' experience within the police service, this workshop invites participants to examine not just what happened, but why it matters - in a time when the verdict could mean life or death.

Was it cold-blooded murder or a tragic accident born of fear, control, and silence? Set against a backdrop of 1950s societal norms, the case probes deep questions around domestic abuse, gender roles, and legal bias. Through active participation, students will explore how evidence, prejudice, and perception shape justice - and how far we've come (or not) since.



#### **The Final Step**

Step into the charged atmosphere of a Victorian courtroom with this immersive, scripted workshop based on the real-life trial of Francis William Neale, accused of murdering his wife, Esther Neale, in Bradford in 1888. Drawing directly from historical sources and structured like a genuine 19th-century court case, this experience invites students to take on the roles of barristers, witnesses, jurors, and the accused in a dramatic re-enactment of a high-stakes criminal trial.

Set against the backdrop of Victorian social values and justice systems, the trial reveals how issues such as domestic abuse, alcohol use, gender roles, and class shaped the outcome of criminal proceedings

#### **Booking Process**

Once you have selected your preferred date, time, and package:

- 2. **Internal Coordination:** Our museum administrator will confirm availability of the courtroom and schedule our team of volunteers to facilitate your visit.
